

Notice of Sale of Tax Liens

Under and by virtue of the authority vested in me by section 105-369 of the General Statutes of North Carolina and pursuant to an order of the Town Council of the Town of Wilkesboro, I have permission to advertise tax liens for the year 2010 upon the real estate described below.
