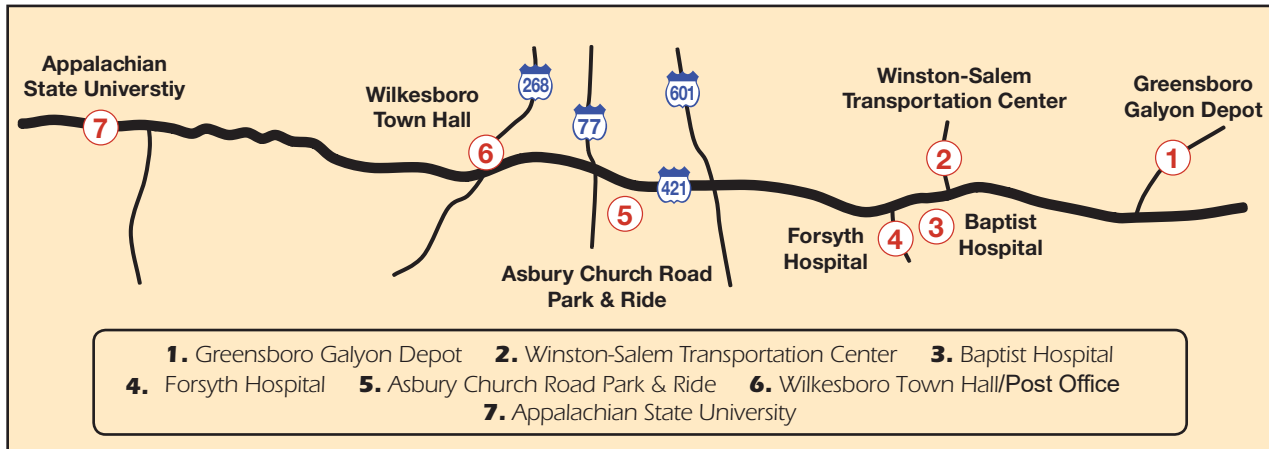


Mountaineer East/West
